Defining Title IX Sexual Harassment

Discrimination or adverse treatment on the basis of sex that limits or excludes a person from participating in programs or activities at Illinois Tech

Title IX Sexual Harassment

What types of Harassment can be Addressed by Title IX?

- Hostile Environment & Unwanted Conduct
- Quid Pro Quo Relationships
- Sexual Violence
 - Sexual Assault
 - Stalking
 - Domestic Violence
 - Dating Violence

When is Sexual Harassment Covered by Title IX?

- When sexual harassment is in the United States
- When sexual harassment is on-campus or is part of our educational program / activity
- When sexual harassment involves current or prospective students, faculty and/or staff.

Illinois Tech Policy

Student - Employee Relationships

- Prohibited between employees and undergraduates
- Prohibited between employees and graduates with an academic or work relationships
- Strongly discouraged between employees and graduates without an academic or work relationship



Consent

Consent is when someone says “yes,” gives permission, or clearly agrees through mutual understanding of words and/or actions to a specific sexual activity.

What happens when one person does not consent?

Elements of Consent

- ◆ Knowing
- ◆ Active
- ◆ Voluntary
- ◆ Present
- ◆ Ongoing

How to Intervene

Being able to safely and effectively step in to help when you see a situation that is harmful or where someone may need support.

It is important to act, but you should never put your own safety at risk!

Elements of Intervention

- ◆ Create a distraction
- ◆ Ask directly
- ◆ Rally others
- ◆ Extend support

Title IX is Here to Help!

I spoke to a student that may have experienced sexual harassment. What should I do?

- Direct them to the Title IX Office for support and resources.

The Title IX office is committed to ensuring student safety.

- We will help guide students to the appropriate resources to address their issue/concern.
- Everyone has a right to the Title IX grievance process, retaliation is prohibited.

When to Report

Employees should report any information they come to learn regarding sex discrimination/ sex-based harassment.

If a student shares with you information that may constitute sexual harassment or sexual misconduct, then you should provide the student with the Title IX Coordinator's contact information and information on how to file a report.

- Set expectations for next steps
